Monsignor Joseph Ansaldi was accused of sexually abusing a male minor child on approximately twenty occasions from approximately 1984 to 1985 when the male child was approximately 15 to 16 years old. At the time of the sexual abuse, Monsignor Ansaldi was employed as the principal of St. Joseph by the Sea High School in Staten Island, New York, and the boy was a student at the school.

The sexual abuse by Monsignor Ansaldi took place in Monsignor Ansaldi's office and included the following: Monsignor Ansaldi forced the boy to bend over in front of a desk. Then Monsignor Ansaldi smacked the boy's buttocks with a paddle. At the same time, Monsignor Ansaldi fondled the boy's genitals over the boy's pants.

The claim settled in 2020 in the mid-five figures.

Monsignor Charles Beausang was accused of sexually abusing a male minor child on one occasion in approximately 1950 when the boy was approximately nine years old. At the time of the claimed sexual abuse, Monsignor Beausang was assigned to Our Lady Star of the Sea Church in Atlantic City, New Jersey.

The sexual abuse by Monsignor Beausang took place inside Our Lady Star of the Sea School, where the male child was a student. Monsignor Beausang told the boy to expose the boy's penis to Monsignor Beausang and to masturbate in front of the boy. Monsignor Beausang began to unfasten the boy's belt buckle, and then the boy ran away.

The claim settled in 2020 in the four figures.

The sexual abuse included Father Bujnowski fondling and stroking the boy’s penis, skin-on-skin.

The sexual abuse by Father Crum included the following: Father Crum gave the boy alcohol to drink, and the boy felt the effects of the alcohol. Father Crum then removed all of his clothing and instructed the boy to remove his own clothing. Father Crum then placed the boy's hand on Father Crum's erect penis, skin-on-skin.

The sexual abuse by Father Curley included the following: Father Curley fondled the boy’s penis and testicles, both over the boy’s clothing and skin-on-skin. Then Father Curley forced the boy to perform oral sex on him until Father Curley ejaculated.

The sexual abuse by Father Donovan included the following: Father Donovan exposed his own penis to the boy, fondled the boy’s penis and testicles over the boy’s clothing, and sodomized the boy.

The claimant passed away prior to the resolution of his claim.

The sexual abuse by Father Ginty took place on a playground near Church of the Nativity and included the following: Father Ginty reached into the top of the girl's top and fondled her breasts, skin-on-skin.

The sexual abuse by Father Healy initially took place in the rectory affiliated with Saints Cosmas and Damian Church and included the following: Father Healy fondled the girl’s breasts and vagina and forced the girl to perform oral sex on Father Healy.

The sexual abuse by Father Rosch took place in St. Joseph's Church and in the rectory affiliated with St. Joseph's Church. The sexual abuse included the following: Father Rosch repeatedly fondled the boy's penis and testicles, skin-on-skin; and Father Rosch repeatedly performed oral sex on the boy.

The claim settled in 2020 in the low six figures.

Father Ryan died in December 2005.

Father Robert F. Ryan was accused of sexually abusing a male minor child on two occasions from approximately 1962 to 1963 when the boy was approximately 14 years old. At the time of the sexual abuse, Father Ryan was assigned to Holy Cross Church in Springfield, Pennsylvania, and the boy was an altar boy at the church and a student at the nearby Holy Cross School.

The sexual abuse by Father Ryan took place inside Holy Cross School and included the following: Father Ryan forced the boy to remove all of the boy’s clothing. Then Father Ryan whipped the boy’s bare back and buttocks with a leather belt multiple times. After whipping the boy, Father Ryan put his hands on the boy’s body where Father Ryan had whipped him.

The claim settled in 2020 in the low five figures.

The sexual abuse by Father Sudol took place during a class field trip to New York. While Father Sudol was swimming in a pool with the girl, Father Sudol reached inside the girl’s bathing suit and penetrated her vagina and rectum with his finger.

Father Wempe was dismissed from the clerical state in 2006.

Father Michael Wempe was accused of sexually abusing a male minor child on at least five occasions from approximately 1974 to 1975 when the boy was approximately 14 to 15 years old. The boy came to know Father Wempe when Father Wempe was serving at St. Rose of Lima Church in Simi Valley, California, though the sexual abuse took place while Father Wempe was assigned to St. Jude's Church in Westlake Village, California.

The sexual abuse by Father Wempe took place in Father Wempe's car and included the following: Father Wempe fondled the boy's penis and masturbated the boy, and Father Wempe exposed his own penis to the boy and forced the boy to masturbate Father Wempe.

Father Zabowski withdrew from ministry in 2002.

Father Theodore Zabowski was accused of sexually abusing a male minor child on approximately ten occasions in approximately 1974 when the boy was approximately 13 years old. At the time of the sexual abuse, Father Zabowski was assigned to St. Lawrence O’Toole Church in Garfield, Pennsylvania.

The sexual abuse by Father Zabowski took place in the rectory affiliated with St. Lawrence O’Toole Church and in various locations in the neighborhood near the church. On multiple occasions, Father Zabowski fondled the boy’s buttocks and/or genitals over the boy’s clothing while Father Zabowski was “play wrestling” with the boy. On one occasion in the rectory, Father Zabowski gave the boy alcohol to drink and then reached into the boy’s clothing, fondling the boy’s penis and testicles skin-on-skin.

The claim settled in 2020 in the low five figures.
